

# **Premarital Coaching Covenant with Craig Morrison**

Congratulations, you both said YES!

I look forward to coaching you toward creating a lasting marriage & officiating your wedding ceremony. I'd like to share a few next steps and some info about our upcoming pre-marital coaching sessions.

## **COMMITMENT**

You and I are committing to a pre-marital coaching relationship because you want to have a healthy marriage and God-honoring ceremony. There are 3 main components to our coaching sessions.

1. **Prepare & Enrich Assessment** : You will receive an email with instructions on how to login and take the assessment. This is our first step and needs to be completed before we meet for the first time. You will need to take the assessment separately and preferably in different locations.
2. **Personalized Ceremony Planning**: We'll spend a great deal dreaming, planning and envisioning the best ceremony for your special day.
3. **Premarital Coaching**: Some of the topics might include money, conflict, sex, role expectations after marriage, and others that pop-up along the way.

Because change happens over time, I recommend six coaching sessions, but we can determine the exact amount after you finish the assessment and meet for the first time.

## **MEETING PROCEDURE**

I'd prefer our first meeting to happen face-to-face if possible. We can meet at the coffee scene or another location you prefer. If our schedules don't allow an in-person meeting we can also arrange a ZOOM meeting if necessary.

Let me know 2-3 options that work for you and we can get started.

## **COACHING SESSIONS**

Coaching sessions normally last around ninety minutes and the next session is scheduled at the end of each meeting.

You may also call me between our scheduled meeting if you need a sounding board or want to share a success with me. I have time between our regular meetings to speak with you if needed, and I enjoy providing this extra level of service. Also, use my e-mail as often as you like.

Our coaching relationship and all information discussed and/or shared during coaching sessions will be kept strictly confidential (unless required by law). Your willingness to be open will be treated with ultimate respect.

Throughout our coaching relationship, the conversations will continue to be direct and personal. You can count on me to be honest and straightforward, asking clarifying questions and making empowering requests. The purpose of our interaction is to hold your focus on YOUR desired outcomes for your wedding day & marriage. You understand that the power of the coaching relationship can only be granted by you -- and you agree to do just that.

Another very important understanding is this covenant does not constitute a counseling relationship. It is a pre-marital coaching relationship only.

## **FINANCIAL EXPECTATIONS**

I request that expenses for travel, meals and lodging (if needed) are covered for the wedding weekend! In addition, my fee for premarital coaching and officiating the wedding ranges from \$300-500. You pick what works best for your budget and if this is an issue I'd be happy to work with you. Please make a check out to Craig Morrison and you can give it to me anytime between now and the wedding rehearsal. It's my honor and privilege to walk with you on this journey toward marriage.

## **CHANGES**

Rescheduling an appointment is easy with advanced text or email before the scheduled coaching session begins. If you have an emergency, we'll work around it.
